## INTERPRETATION AND DEFINITIONS

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or plural.

### DEFINITIONS

**Company** (referred to as either the" Company, We, or Us) refers to J.E.T. Insurance Agency

**Account** means an account created for You to access our services.

**Device** means any device used to access the services we provide for you.

**Personal Data** is any information that relates to an identified or identifiable individual.

**Usage Data** refers to data collected automatically, either generated by the use of the Company or from the service infrastructure itself.

**Website** refers to J.E.T. Insurance Agency, accessible from [www.jetinsurance.us](http://www.jetinsurance.us)

**You** means the individual accessing or using services of the Company

## COLLECTING AND USING YOUR PERSONAL DATA

## **Types of data collected**

### **Personal Data**

While using the services of the Company, We may ask You to provide Us with certain personally identifiable information that can be used to contact or identify You.

Personally identifiable information may include, but is not limited to:

Email address

First and last name

Phone number

State of residence

### **Usage Data**

Usage data is collected automatically when using the services of the Company.

Usage data may include information such as your device's internet protocol address, browser type, browser version, the time and date of your usage, the time spent on the services the Company uses.

When You access the services by a through a mobile device, We may collect certain information automatically, including but not limited to, the type of mobile device You use, Your mobile device unique ID, the IP address of Your mobile device, Your mobile operating system, the type of mobile internet browser You use, unique device identifiers and other diagnostic data.

We may also collect information Your browser sends whenever You use Our services.

### **Use of your Personal Data**

**The Company may use Your personal Data for the following purposes:**

To contact You

To manage Your Company account

To manage Your requests

We will not share your information with anyone outside the scope of the Business.

## **YOUR RIGHTS**

### **Mobile Opt-In Data**

No mobile opt-in data will be shared with third parties or affiliates for marketing or promotional purposes. This excludes text messaging originator opt-in data and consent, which will not be shared with any third parties.

### **SMS Terms and Conditions**
